ORDER:

In the letter read above, the Project Director, Tamil Nadu Health Systems Reforms Project has stated that the planning process for the preparation of the Tamil Nadu Health Systems Reforms Project to be implemented with funding support from World Bank has reached an advanced stage. The Project Appraisal is scheduled to be held on 12.11.2018. The Project Negotiations with the Department of Economic Affairs and World Bank is scheduled for December 2018. The World Bank Board approval is expected in February 2019 and during the same month the Project Agreement is likely to be signed. The Project is expected to become effective from March 2019. The proposed total Project cost is estimated at Rs. 2685.91 crores and the project implementation period will be for 5 years from 2019 to 2024.

- 2. The Project Director, Tamil Nadu Health Systems Reforms Project has further stated that as per the Department of Economic Affairs filters by the time of the appraisal of the project the Project Management Structure is to be established by the State Government. In this Project a four tier Project Management Structure is proposed namely
 - 1. State Empowered Committee headed by the Chief Secretary
 - 2. Project Steering Committee headed by the Principal Secretary, Health and Family Welfare Department
 - 3. Project Management Unit headed by the Project Director
 - 4. District Project Management Unit headed by the Joint Director

There will be a District Project Monitoring Committee Headed by the District Collector.

3. The Project Director, Tamil Nadu Health Systems Reforms Project has stated that as per the Project design, the State Empowered Committee will have high level representation from the Departments concerned of the State Government with delegated administrative and financial powers to significantly improve the functioning of the Tamil Nadu Health Systems Reforms Project. The Project is an externally supported Project and is time bound. It is highly target oriented and results are to be achieved with intensified monitoring of delivery of outputs/achievements/results and

will be subjected to periodic reviews by World Bank in order to qualify for getting disbursement of funds from World Bank.

- 4. The Project Director, Tamil Nadu Health Systems Project has requested the Government to constitute the State Empowered Committee.
- 5. The Government after careful consideration of the proposal of the Project Director, Tamil Nadu Health Systems Project have decided to accept the proposal. Accordingly, the Government constitute the State Empowered Committee for the Tamil Nadu Health Systems Reforms Project with the following members along with the duties and responsibilities.

(iii) Duties and Responsibilities of the State Empowered Committee

- 1. To make major policy decisions to attain the Project goals.
- 2. To approve the Project activities.
- 3. To provide Administrative and Financial sanction for the activities of the Project.
- 4. Ensuring Interdepartmental coordination and address issues related to convergence of services.

5. To review the linkages between the centrally sponsored schemes and other schemes of the Government

(iv) Powers of the State Empowered Committee

- 1. To sanction expenditure upto Rs. 5.00 crores for Civil works including repair and renovation, Equipment and services
- 2. If the Project proposal submitted to the State Empowered Committee exceeds the Committee's Financial powers the activities and budget shall be cleared by the State Empowered Committee subject to approval in circulation by the concerned Ministers and Chief Minister, as the need be.

This Committee shall meet once in 6 months and also meet in between based on requirement. In urgency the proposal should be circulated among the members and get approved. The decision of the State Empowered Committee should be communicated as Government Orders from the Health and Family Welfare Department and shall come into force from the day the Project Agreement is signed which will be notified to the Government by the Project Director.
