ORDER:

The Hon'ble Minister (Health and Family Welfare), Government of Tamil Nadu has made an announcement on the floor of Tamil Nadu State Legislative Assembly for the year 2017-18, among others, that the State Health System Resource Centre (SHSRC), a dedicated system for policy and strategy development at a cost of Rs.82.00 lakh will be established.

2. The Mission Director, State Health Society has stated that a proposal for establishment of State Health System Resource Centre (SHSRC) at an estimated cost of Rs.82.40 lakh was included in the Programme Implementation Plan (PIP) for the year 2017-2018 to function as an "Apex-body" for providing technical assistance and also evidence based inputs to National Health Mission for the purpose of decision making. Government of India have accorded sanction in Record of proceedings 2017-2018 as proposed at Rs.82.40 lakh for the establishment of the above facility except the cost for Human Resources. The Record of proceedings 2017-18 was placed before the Executive Committee Meeting held on 23.06.2017 and the committee has also approved the Record of Proceedings. Subsequently, a specific proposal has also been approved by the Executive Sub Committee, vide Circulation Note No.10 to establish the same at Indian Institute of Technology Madras, Chennai. Also, a proposal for the Human Resource cost of State Health Accounts (SHA) wing, which is one of the core divisions under the State Health System Resource, was included in the Programme Implementation Plan (PIP) for the year 2017-18 and was also approved by the Government of India in Record of Proceedings 2017-18 for Rs 07.26 lakh to support the cost of Human Resources for State Health Accounts wing.

3. The Mission Director, State Health Society has further stated that upon establishment, State Health Communication Resource Centre (SHCRC) and State Health Data Resource Centre (SHDRC) will function under State Health System Resource Centre (SHSRC). In this connection, the Mission Director, National Health

Mission has stated that a memorandum of understanding (MoU) will be signed between National Health Mission (NHM) Tamil Nadu and Director of Indian Institute of Technology in this regard. He has further added that Administrative control and implementation of State Health System Resource Centre activities will be under the purview of Indian Institute of Technology Madras, Chennai and also stated that State Health System Resource Centre being established as a technical assistance body to lead the various health activities across the State, the provision of Governing Body and an Executive Committee may be considered as essential components to run the centre effectively.

4. The proposal of establishment of State Health System Resource Centre (SHSRC) with budgetary provision of Rs.82.40 lakh in Indian Institute of Technology Madras with Human Resource cost of State Health Account wings has been approved in the 33rd Executive Committee Meeting.

5. The Mission Director, State Health Society has therefore requested the Government Orders in this regard.

6. The Government after careful consideration have decided to accept the proposal of the Mission Director, State Health Society and accordingly issue following orders:-

- i. The Mission Director, National Health Mission is permitted to establish State Health System Resource Centre in Indian Institute of Technology, Chennai as an independent unit with a budgetary provision of Rs.82.40 lakh
- ii. The Governing Body and Executive Committee of the State Health System Resource Centre be constituted with the following members.
